UNMAS and UNAMI Host Resource Mobilization Workshop for IKMAA



UNMAS, in partnership with the United Nations Assistance Mission for Iraq (UNAMI), organized a basic level training workshop on resource mobilization for 10 staff members of the Iraqi Kurdistan Mine Action Agency (IKMAA).

The workshop focused on a holistic approach to developing a resource mobilization strategy, including sessions on Strengths, Weaknesses, Opportunities, and Threats (SWOT) analysis, outlining relevant strategic goals, formulating a cohesive communications and media strategy, and gender. An advanced version of the training is planned for next year.

UNMAS held a three-day workshop for 12 staff members of the Directorate of Mine Action (DMA) aimed at supporting the Risk Education and Media Department with the tools and knowledge required for enhancing its monitoring and evaluation in a gender-responsive manner.

The workshop focused on integrating gender in risk education activities, ensuring that the needs of girls, boys, women, and men are taken into consideration.

Commenting on the workshop, Rana Sherwanee, Head of DMA's Risk Education and Media department, said: "This was a crucial workshop as it

UNMAS & Partners' Achievements in December 2019

5,367 m² of high priority areas surveyed, 13,046 m² cleared, and 44 explosive hazard items removed.

18 assessments and surveys completed in support of stabilization and humanitarian efforts.

1,408 risk education sessions delivered to 26,908 beneficiaries of which 44% were female and 74% were children.



*Figures for the Mine Action sector are provided by the Directorate for Mine Action (DMA) and the Iraqi Kurdistan Mine Action Agency (IKMAA). Statistics obtained from the Government databases might not fully reflect the up-to-date numbers as reports are submitted on a rolling basis. For these reasons, the figures reported have to be considered as the absolute minimum and only reflect the achievements of humanitarian actors (not the Iraqi Security Forces)



Established in 1997, the **United Nations Mine Action Service** (UNMAS) works to eliminate the threat posed by mines, explosive remnants of war and improvised explosive devices by coordinating United Nations mine action, leading operational responses at the country level, and supporting the development of standards, policies and norms. As a specialized service of the United Nations located within the Department of Peace Operations, UNMAS operates under UN legislative mandates of both the General Assembly and the Security Council. UNMAS also responds to specific requests for support from the UN Secretary-General or designated official. UN Security Council Resolution 2365 (2017) the first stand-alone text on mine action, "Expresses grave concern over the threat that landmines, explosive remnants of war and improvised explosive devices pose to civilians, refugees returning to their homes, ...and stresses the need to undertake appropriate measures to mitigate this danger effectively."
